ON ORTHOGONAL TENSORS AND BEST RANK-ONE APPROXIMATION RATIO

ABSTRACT. As is well known, the smallest possible ratio between the spectral norm and the Frobenius norm of an $m \times n$ matrix with $m \leq n$ is $1/\sqrt{m}$ and is (up to scalar scaling) attained only by matrices having pairwise orthonormal rows. In the present paper, the smallest possible ratio between spectral and Frobenius norms of $n_1 \times \cdots \times n_d$ tensors of order d , also called the best rank-one approximation ratio in the literature, is investigated. The exact value is not known for most configurations of $n_1 \leq \cdots \leq n_d$. Using a natural definition of orthogonal tensors over the real field (resp. unitary tensors over the complex field), it is shown that the obvious lower bound $1/\sqrt{n_1 \cdots n_{d-1}}$ is attained if and only if a tensor is orthogonal (resp. unitary) up to scaling. Whether or not orthogonal or unitary tensors exist depends on the dimensions n_1, \dots, n_d and the field. A connection between the (non)existence of real orthogonal tensors of order three and the classical Hurwitz problem on composition algebras can be established: existence of orthogonal tensors of size $\ell \times m \times n$ is equivalent to the admissibility of the triple $[\ell, m, n]$ to Hurwitz problem. Some implications for higher-order tensors are then given. For instance, real orthogonal $n \times \cdots \times n$ tensors of order $d \geq 3$ do exist, but only when $n = 1, 2, 4, 8$. In the complex case, the situation is more drastic: unitary tensors of size $\ell \times m \times n$ with $\ell \leq m \leq n$ exist only when $\ell m \leq n$. Finally, some numerical illustrations for spectral norm computation are presented.

1. INTRODUCTION

Let \mathbb{K} be \mathbb{R} or \mathbb{C} . Given positive integers $d \geq 2$ and n_1, \dots, n_d , we consider the tensor product

$$\mathbb{V} = V^1 \otimes \cdots \otimes V^d$$

of Euclidean \mathbb{K} -vector spaces V^1, \dots, V^d of dimensions $\dim(V^\mu) = n_\mu$, $\mu = 1, \dots, d$. The space \mathbb{V} is generated by the set of *elementary* (or *rank-one*) tensors

$$\mathcal{C}_1 = \{u^1 \otimes \cdots \otimes u^d : u^1 \in V^1, \dots, u^d \in V^d\}.$$

In general, elements of \mathbb{V} are called tensors. The natural inner product on the space \mathbb{V} is uniquely determined by its action on decomposable tensors via

$$\langle u^1 \otimes \cdots \otimes u^d, v^1 \otimes \cdots \otimes v^d \rangle_{\mathbb{F}} = \prod_{\mu=1}^d \langle u^\mu, v^\mu \rangle_{V^\mu}.$$

This inner product is called the Frobenius inner product, and its induced norm is called the Frobenius norm, denoted by $\|\cdot\|_{\mathbb{F}}$.

1.1. Spectral norm and best rank-one approximation. The *spectral norm* (also called *injective norm*) of a tensor $\mathbf{X} \in \mathbb{V}$ is defined as

$$(1.1) \quad \|\mathbf{X}\|_2 = \max_{\substack{\mathbf{Y} \in \mathcal{C}_1 \\ \|\mathbf{Y}\|_F=1}} |\langle \mathbf{X}, \mathbf{Y} \rangle_F| = \max_{\|u^1\|_{V^1}=\dots=\|u^d\|_{V^d}=1} |\langle \mathbf{X}, u^1 \otimes \dots \otimes u^d \rangle_F|.$$

Note that the second max is achieved by some $u^1 \otimes \dots \otimes u^d$ since the spaces V^μ 's are finite dimensional. Hence the first max is also achieved. Checking the norm properties is an elementary exercise.

Since the space \mathbb{V} is finite dimensional, the Frobenius norm and spectral norm are equivalent. It is clear from the Cauchy-Schwarz inequality that

$$\|\mathbf{X}\|_2 \leq \|\mathbf{X}\|_F.$$

The constant one in this estimate is optimal, since equality holds for elementary tensors.

For the reverse estimate, the optimal constant c in

$$\|\mathbf{X}\|_F \leq c \|\mathbf{X}\|_2$$

is unknown in general and may depend not only on d, n_1, \dots, n_d , but also on \mathbb{K} . Formally, the optimal value is defined as

$$(1.2) \quad \text{App}(\mathbb{V}) \equiv \text{App}_d(\mathbb{K}; n_1, \dots, n_d) := \min_{\mathbf{X} \neq 0} \frac{\|\mathbf{X}\|_2}{\|\mathbf{X}\|_F} = \min_{\|\mathbf{X}\|_F=1} \|\mathbf{X}\|_2.$$

Note that by continuity and compactness, there always exists a tensor \mathbf{X} achieving the minimal value.

The task of determining the constant $\text{App}(\mathbb{V})$ was posed by Qi [21], who called it the *best-rank one approximation ratio* of the tensor space \mathbb{V} . This terminology originates from the important geometrical fact that the spectral norm of a tensor measures its approximability by elementary tensors. To explain this, we first recall that \mathcal{C}_1 , the set of elementary tensors, is closed and hence every tensor \mathbf{X} admits a best approximation (in Frobenius norm) in \mathcal{C}_1 . Therefore, the problem of finding $\mathbf{Y}_1 \in \mathcal{C}_1$ such that

$$(1.3) \quad \|\mathbf{X} - \mathbf{Y}_1\|_F = \inf_{\mathbf{Y} \in \mathcal{C}_1} \|\mathbf{X} - \mathbf{Y}\|_F$$

has at least one solution. Any such solution is called a *best rank-one approximation to \mathbf{X}* . The relation between the best rank-one approximation of a tensor and its spectral norm is given as follows.

Proposition 1.1. *A tensor $\mathbf{Y}_1 \in \mathcal{C}_1$ is a best rank-one approximation to $\mathbf{X} \neq 0$ if and only if the following holds:*

$$\|\mathbf{Y}_1\|_F = \left\langle \mathbf{X}, \frac{\mathbf{Y}_1}{\|\mathbf{Y}_1\|_F} \right\rangle_F = \|\mathbf{X}\|_2.$$

Consequently,

$$(1.4) \quad \|\mathbf{X} - \mathbf{Y}_1\|_F^2 = \|\mathbf{X}\|_F^2 - \|\mathbf{X}\|_2^2.$$

The original reference for this observation is hard to trace back; see e.g., [15]. It is now considered a folklore. The proof is easy from some least-square argument based on the fact that \mathcal{C}_1 is a \mathbb{K} -double cone, i.e., $\mathbf{Y} \in \mathcal{C}_1$ implies $t\mathbf{Y} \in \mathcal{C}_1$ for all $t \in \mathbb{K}$.

By Proposition 1.1, the rank-one approximation ratio $\text{App}(\mathbb{V})$ is equivalently seen as the worst-case angle between a tensor and its best rank-one approximation:

$$\text{App}(\mathbb{V}) = \min_{\mathbf{X} \neq 0} \frac{|\langle \mathbf{X}, \mathbf{Y}_1 \rangle_{\mathbb{F}}|}{\|\mathbf{X}\|_{\mathbb{F}} \cdot \|\mathbf{Y}_1\|_{\mathbb{F}}},$$

where $\mathbf{Y}_1 \in \mathcal{C}_1$ depends on \mathbf{X} . As an application, the estimation of $\text{App}(\mathbb{V})$ from below has some important implication for the analysis of truncated steepest descent methods for tensor optimization problems; see [26].

Combining (1.2) and (1.4) one obtains

$$\text{App}(\mathbb{V})^2 = 1 - \max_{\|\mathbf{X}\|_{\mathbb{F}}=1} \min_{\mathbf{Y} \in \mathcal{C}_1} \|\mathbf{X} - \mathbf{Y}\|_{\mathbb{F}}^2.$$

1.2. Nuclear norm. The nuclear norm (also called *projective norm*) of a tensor $\mathbf{X} \in \mathbb{V}$ is defined as

$$(1.5) \quad \|\mathbf{X}\|_* = \inf \left\{ \sum_k \|\mathbf{Z}_k\|_{\mathbb{F}} : \mathbf{X} = \sum_k \mathbf{Z}_k \text{ with } \mathbf{Z}_k \in \mathcal{C}_1 \right\}.$$

One can show (see, e.g., [4] or [18]) that the dual of the nuclear norm is the spectral norm (in tensor products of Banach spaces the spectral norm is usually defined in this way):

$$\|\mathbf{X}\|_2 = \max_{\|\mathbf{Y}\|_*=1} |\langle \mathbf{X}, \mathbf{Y} \rangle_{\mathbb{F}}|.$$

By a well-known duality principle in finite-dimensional spaces (see, e.g., [10, Thm. 5.5.14]), the nuclear norm is then also the dual of the spectral norm:

$$\|\mathbf{X}\|_* = \max_{\|\mathbf{Y}\|_2=1} |\langle \mathbf{X}, \mathbf{Y} \rangle_{\mathbb{F}}|.$$

This immediately implies that

$$(1.6) \quad \|\mathbf{X}\|_{\mathbb{F}}^2 \leq \|\mathbf{X}\|_2 \|\mathbf{X}\|_*.$$

In particular, $\|\mathbf{X}\|_{\mathbb{F}} \leq \|\mathbf{X}\|_*$ and equality holds if and only if \mathbf{X} is an elementary tensor. However, as in the spectral norm, the exact value of $\max_{\mathbf{X} \neq 0} \|\mathbf{X}\|_* / \|\mathbf{X}\|_{\mathbb{F}}$ seems to be unknown in almost all tensor spaces. One obvious bound that follows from the definition (1.5) and the Cauchy-Schwarz inequality is

$$(1.7) \quad \frac{\|\mathbf{X}\|_*}{\|\mathbf{X}\|_{\mathbb{F}}} \leq \sqrt{\text{rank}_{\perp}(\mathbf{X})} \leq \sqrt{\min_{\nu=1, \dots, d} \prod_{\mu \neq \nu} n_{\mu}},$$

where $\text{rank}_{\perp}(\mathbf{X})$ is the orthogonal rank of \mathbf{X} ; see section 2.1.

1.3. Matrices. It is instructive to inspect the matrix case. In this case, it is well known that

$$(1.8) \quad \text{App}_2(\mathbb{K}; m, n) = \frac{1}{\sqrt{\min(m, n)}}.$$

In fact, let $\mathbf{X} \in \mathbb{K}^{m \times n}$ have $\text{rank}(\mathbf{X}) = R$ and

$$\mathbf{X} = \sum_{k=1}^R \sigma_k u_k \otimes v_k$$

be a singular value decomposition (SVD) with orthonormal systems $\{u_1, \dots, u_R\}$ and $\{v_1, \dots, v_R\}$, and $\sigma_1 \geq \sigma_2 \geq \dots \geq \sigma_R > 0$. Then by a well-known theorem [7, Thm. 2.4.8] the best rank-one approximation in Frobenius norm is given by

$$\mathbf{X}_1 = \sigma_1 u_1 \otimes v_1,$$

producing an approximation error

$$\|\mathbf{X} - \mathbf{X}_1\|_F^2 = \sum_{k=2}^R \sigma_k^2.$$

The spectral norm is

$$\|\mathbf{X}\|_2 = \|\mathbf{X}_1\|_F = \sigma_1 \geq \frac{\|\mathbf{X}\|_F}{\sqrt{R}}.$$

Here equality is attained only for a matrix with $\sigma_1 = \dots = \sigma_R = \frac{\|\mathbf{X}\|_F}{\sqrt{R}}$. Obviously, (1.8) follows when $R = \min(m, n)$. Assuming $m \leq n$, we see that a matrix \mathbf{X} achieving equality satisfies $\mathbf{X}\mathbf{X}^* = \frac{\|\mathbf{X}\|_F^2}{m} I_m$, that is, \mathbf{X} is a multiple of a matrix with pairwise orthonormal rows.

Likewise it holds for the nuclear norm of a matrix that

$$\|\mathbf{X}\|_* = \sum_{k=1}^R \sigma_k \leq \sqrt{\min(m, n)} \cdot \|\mathbf{X}\|_F,$$

and equality is achieved (in case $m \leq n$) if and only if \mathbf{X} is a multiple of a matrix with pairwise orthonormal rows.

1.4. Contribution and outline. As explained in section 2.1 below, it is easy to deduce the “trivial” lower bound

$$(1.9) \quad \text{App}_d(\mathbb{K}; n_1, \dots, n_d) \geq \frac{1}{\sqrt{\min_{\nu=1, \dots, d} \prod_{\mu \neq \nu} n_\mu}}$$

for the best rank-one approximation ratio of a tensor space. From (1.8) we see that this lower bound is sharp for matrices for any (m, n) and is attained only at matrices with pairwise orthonormal rows or columns, or their scalar multiples (in this paper, with a slight abuse of notation, we call such matrices *orthogonal* when $\mathbb{K} = \mathbb{R}$ (resp. *unitary* when $\mathbb{K} = \mathbb{C}$)). A key goal in this paper is to generalize this fact to higher-order tensors.

In section 2 we first review some characterizations of spectral norm and available bounds on the best-rank one approximation ratio.

In section 3 we show that the trivial rank-one approximation ratio (1.9) is achieved if and only if a tensor is a scalar multiple of an *orthogonal* (resp. *unitary*) tensor, where the notion of orthogonality (resp. unitarity) is defined in a way that generalizes orthogonal (resp. unitary) matrices very naturally. We also prove corresponding extremal properties of orthogonal (resp. unitary) tensors regarding the ratio of the nuclear and Frobenius norms.

We then study in section 4 further properties of orthogonal tensors, in particular focusing on their existence. Surprisingly, unlike the matrix case where orthogonal/unitary matrices exist for any (m, n) , orthogonal tensors often do not exist, depending on the configuration of (n_1, \dots, n_d) and the field \mathbb{K} . In the first nontrivial case $d = 3$ over $\mathbb{K} = \mathbb{R}$, we show that the (non)existence of orthogonal tensors is

connected to the classical *Hurwitz problem*. This problem has been studied extensively, and in particular a result by Hurwitz himself [11] implies that an $n \times n \times n$ orthogonal tensor exists only for $n = 1, 2, 4$ and 8 , and is then essentially equivalent to a multiplication tensor in the corresponding composition algebras \mathbb{R}^n . These algebras are the reals ($n = 1$), the complex numbers ($n = 2$), the quaternions ($n = 4$) and the octonions ($n = 8$). We further generalize Hurwitz' result to the case $d > 3$. These observations might give the impression that considering orthogonal tensors is futile. However, the situation is vastly different when the tensor is not cubical, that is, when n_μ 's take different values. While a complete analysis of the (non)existence of non-cubic real orthogonal tensors is largely left an open problem, we investigate this problem and derive some cases where orthogonal tensors do exist. When $\mathbb{K} = \mathbb{C}$, the situation turns out to be more restrictive: we show that when $d \geq 3$, unitary cubic tensors do not exist unless trivially $n = 1$, and non-cubic ones do exist only in the trivial case of extremely "tall" tensors, that is, if $n_\nu \geq \prod_{\mu \neq \nu} n_\mu$ for some dimension n_ν .

Unfortunately, we are currently unable to provide the exact value or sharper lower bounds on the best-rank one approximation ratio of tensor spaces where orthogonal (resp. unitary) tensors do not exist. The only thing we can conclude is that in these spaces the bound (1.9) is not sharp. For example,

$$\text{App}_3(\mathbb{R}; n, n, n) > \frac{1}{n}$$

for all $n \neq 1, 2, 4, 8$. However, recent results on random tensors imply that the trivial lower bound provides the correct order of magnitude, that is,

$$\text{App}_d(\mathbb{K}; n_1, \dots, n_d) = O\left(\frac{1}{\sqrt{\min_{\nu=1, \dots, d} \prod_{\mu \neq \nu} n_\mu}}\right),$$

at least when $\mathbb{K} = \mathbb{R}$; see section 2.4.

Some numerical experiments for spectral norm computation are conducted in section 5, comparing algorithms from the Tensolab toolbox [27] with an alternating SVD (ASVD) method proposed in [3, Sec. 3.3] and later in [5]. In particular, computations for random $n \times n \times n$ tensors indicate that $\text{App}_3(\mathbb{R}; n, n, n)$ behaves like $O(1/n)$.

Some more notational conventions. For convenience, and without loss of generality, we will identify the space \mathbb{V} with the space $\mathbb{K}^{n_1} \otimes \dots \otimes \mathbb{K}^{n_d} \cong \mathbb{K}^{n_1 \times \dots \times n_d}$ of d -way arrays $[\mathbf{X}(i_1, \dots, i_d)]$ of size $n_1 \times \dots \times n_d$, where every \mathbb{K}^{n_μ} is endowed a standard Euclidean inner product $x^H y$. This is achieved by fixing orthonormal bases in the spaces V^μ .

In this setting, an elementary tensor has *entries*

$$[u^1 \otimes \dots \otimes u^d]_{i_1, \dots, i_d} = u^1(i_1) \dots u^d(i_d).$$

The Frobenius inner product of two tensors is then

$$\langle \mathbf{X}, \mathbf{Y} \rangle_F = \sum_{i_1, \dots, i_d} \overline{\mathbf{X}(i_1, \dots, i_d)} \mathbf{Y}(i_1, \dots, i_d).$$

It is easy to see that the spectral norm defined below is not affected by the identification of $\mathbb{K}^{n_1 \times \dots \times n_d}$ and $V^1 \otimes \dots \otimes V^d$ in the described way.

For readability it is also useful to introduce the notation

$$\mathbb{V}^{[\mu]} := \mathbb{K}^{n_1} \otimes \cdots \otimes \mathbb{K}^{n_{\mu-1}} \otimes \mathbb{K}^{n_{\mu+1}} \otimes \cdots \otimes \mathbb{K}^{n_d} \cong \mathbb{K}^{n_1 \times \cdots \times n_{\mu-1} \times n_{\mu+1} \times \cdots \times n_d},$$

which is a tensor product space of order $d - 1$. The set of elementary tensors in this space is denoted by $\mathcal{C}_1^{[\mu]}$.

An important role in this work is played by slices of a tensor and their linear combinations. Formally, such linear combinations are obtained as partial contractions with vectors. We use standard notation [15] for these contractions: let $\mathbf{X}_{i_\mu} = \mathbf{X}(:, \dots, :, i_\mu, :, \dots, :)$ $\in \mathbb{V}^{[\mu]}$ for $i_\mu = 1, \dots, n_\mu$, denoting the slices of the tensor $\mathbf{X} \in \mathbb{K}^{n_1 \times \cdots \times n_d}$ perpendicular to mode μ . Given $u^\mu \in \mathbb{K}^{n_\mu}$, the mode- μ product of \mathbf{X} and u^μ is defined as

$$\mathbf{X} \times_\mu u^\mu := \sum_{i_\mu=1}^{n_\mu} u(i_\mu) \mathbf{X}_{i_\mu} \in \mathbb{V}^{[\mu]}.$$

Correspondingly, partial contractions with more than one vectors are obtained by applying single contractions repeatedly, for instance

$$\mathbf{X} \times_1 u^1 \times_2 u^2 := (\mathbf{X} \times_2 u^2) \times_1 u^1.$$

With this notation, we have

$$(1.10) \quad \langle \mathbf{X}, u^1 \otimes \cdots \otimes u^d \rangle_{\mathbb{F}} = \mathbf{X} \times_1 u^1 \times_2 u^2 \cdots \times_d u^d = \langle \mathbf{X} \times_1 u^1, u^2 \otimes \cdots \otimes u^d \rangle_{\mathbb{F}}.$$

2. PREVIOUS RESULTS ON BEST RANK-ONE APPROXIMATION RATIO

2.1. Lower bounds from orthogonal rank. Lower bounds of $\text{App}(\mathbb{V})$ can be obtained from expansion of tensors into orthogonal decomposable tensors. For any $\mathbf{X} \in \mathbb{V}$, let R be an integer such that

$$(2.1) \quad \mathbf{X} = \sum_{k=1}^R \mathbf{Z}_k$$

with $\mathbf{Z}_1, \dots, \mathbf{Z}_R \in \mathcal{C}_1$ being mutually orthogonal. We can assume that $\|\mathbf{Z}_1\|_{\mathbb{F}} \geq \|\mathbf{Z}_2\|_{\mathbb{F}} \geq \cdots \geq \|\mathbf{Z}_R\|_{\mathbb{F}}$, hence that $\|\mathbf{Z}_1\|_{\mathbb{F}} \geq \frac{\|\mathbf{X}\|_{\mathbb{F}}}{\sqrt{R}}$, and so

$$(2.2) \quad \frac{\|\mathbf{X}\|_2}{\|\mathbf{X}\|_{\mathbb{F}}} \geq \frac{|\langle \mathbf{X}, \mathbf{Z}_1 \rangle_{\mathbb{F}}|}{\|\mathbf{X}\|_{\mathbb{F}} \cdot \|\mathbf{Z}_1\|_{\mathbb{F}}} = \frac{\|\mathbf{Z}_1\|_{\mathbb{F}}}{\|\mathbf{X}\|_{\mathbb{F}}} \geq \frac{1}{\sqrt{R}}.$$

For each \mathbf{X} the smallest possible value of R for which a decomposition (2.1) is possible is called the *orthogonal rank* of \mathbf{X} [14], denoted by $\text{rank}_{\perp}(\mathbf{X})$. Then, it follows that

$$(2.3) \quad \text{App}(\mathbb{V}) \geq \frac{1}{\sqrt{\text{rank}_{\perp}(\mathbf{X})}} \quad \text{for all } \mathbf{X} \in \mathbb{V}.$$

A possible strategy is to estimate the maximal possible orthogonal rank of the space \mathbb{V} (which is an open problem in general). For instance, by estimating orthogonal rank, Kong and Meng [16] showed that

$$\text{App}_3(\mathbb{R}; 2, n_1, n_2) = \begin{cases} 1/\sqrt{2n_1} & n_1 \text{ is even} \\ 1/\sqrt{2n_1 - 1} & n_1 \text{ is odd} \end{cases}$$

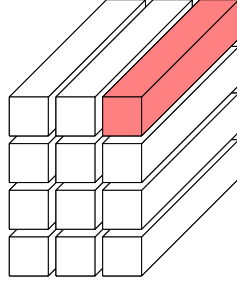
assuming that $2 \leq n_1 \leq n_2$. The same paper also contains the result

$$\text{App}_3(\mathbb{C}; 2, 2, 2) \geq \frac{1}{\sqrt{3}}.$$

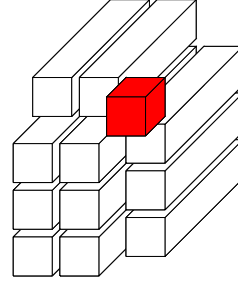
The trivial lower bound (1.9) is obtained by noticing that every tensor can be decomposed into orthogonal elementary tensors that match the entries of the tensor in single parallel *fibers*¹ and are zero otherwise. Depending on the orientation of the fibers, there are $\prod_{\mu \neq \nu} n_\mu$ of them. Therefore,

$$(2.4) \quad \max_{\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}} \text{rank}_\perp(\mathbf{X}) \leq \min_{\nu=1, \dots, d} \prod_{\mu \neq \nu} n_\mu$$

and (1.9) follows from (2.3); see Figure 1(A).



(A) Orthogonal decomposition of a tensor into its longest fibers. A fiber of largest Euclidean norm provides a lower bound of the spectral norm.



(B) Normal form using an orthonormal tensor product basis that includes a normalized best rank-one approximation. The red entry equals the spectral norm.

It is interesting and useful to know that after a suitable orthonormal change of basis we can always assume that the entry $\mathbf{X}(1, \dots, 1)$ of a tensor $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$ equals its spectral norm. In fact, let $\|\mathbf{X}\|_2 \cdot (u_1^1 \otimes \dots \otimes u_1^d)$ be a best rank-one approximation of \mathbf{X} with u_1^1, \dots, u_1^d all normalized to one. Then we can extend u_1^μ to orthonormal bases $\{u_1^\mu, \dots, u_{n_\mu}^\mu\}$ for every μ to obtain a representation

$$\mathbf{X} = \sum_{i_1=1}^{n_1} \dots \sum_{i_d=1}^{n_d} \mathbf{C}(i_1, \dots, i_d) u_{i_1}^1 \otimes \dots \otimes u_{i_d}^d.$$

We may identify \mathbf{X} with its new coefficient tensor \mathbf{C} , in particular they have the same spectral norm. Since (see Proposition 1.1 for the second equality)

$$\mathbf{C}(1, \dots, 1) = \langle \mathbf{X}, u_1^1 \otimes \dots \otimes u_1^d \rangle_F = \|\mathbf{X}\|_2 = \|\mathbf{C}\|_2$$

and considering the overlap with fibers, we see that all other entries of any fiber that contains $\mathbf{C}(1, \dots, 1)$ must be zeros; see Figure 1(B). This “spectral normal form” of the tensor \mathbf{X} can be used to study uniqueness and perturbation of best rank-one approximation of tensors [13]. For our purposes, the following conclusion will be of interest, which is immediately obtained by decomposing the tensor \mathbf{C} into fibers.

Proposition 2.1. *Let $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$. For any $\nu = 1, \dots, d$, there exists an orthogonal decomposition (2.1) into $R = \prod_{\mu \neq \nu} n_\mu$ mutually orthogonal elementary tensors \mathbf{Z}_k , such that \mathbf{Z}_1 is a best rank-one approximation of \mathbf{X} . In particular, $\|\mathbf{Z}_1\|_F = \|\mathbf{X}\|_2$.*

¹A fiber is a subset of entries (i_1, \dots, i_d) in a tensor, in which one index i_μ varies from 1 to n_μ , while other indices are kept fixed.

2.2. Lower bounds from slices. The spectral norm admits two useful characterizations in terms of slices. Let again $\mathbf{X}_{i_\mu} = \mathbf{X}(\cdot, \dots, \cdot, i_\mu, \cdot, \dots, \cdot) \in \mathbb{V}^{[\mu]}$ denote the slices of a tensor \mathbf{X} perpendicular to mode μ . The following formula is immediate from (1.10) and the commutativity of partial contractions:

$$\|\mathbf{X}\|_2 = \max_{\substack{u^\mu \in \mathbb{K}^{n_\mu} \\ \|u^\mu\|_{V^\mu} = 1}} \|\mathbf{X} \times_\mu u^\mu\|_2 = \max_{\substack{u^\mu \in \mathbb{K}^{n_\mu} \\ \|u^\mu\|_{V^\mu} = 1}} \left\| \sum_{i_\mu=1}^{n_\mu} u^\mu(i_\mu) \mathbf{X}_{i_\mu} \right\|.$$

By choosing $u^\mu = e_i$ (the i th column of the identity matrix), we conclude that

$$(2.5) \quad \|\mathbf{X}_{i_\mu}\|_2 \leq \|\mathbf{X}\|_2$$

for all slices.

We also have the following.

Proposition 2.2.

$$\|\mathbf{X}\|_2 = \max_{\substack{\mathbf{Z} \in \mathcal{C}_1^{[\mu]} \\ \|\mathbf{Z}\|_F = 1}} \left(\sum_{i_\mu=1}^{n_\mu} |\langle \mathbf{X}_{i_\mu}, \mathbf{Z} \rangle_F|^2 \right)^{1/2}.$$

Proof. Since the spectral norm is invariant under permutation of indices, it is enough to show this for $\mu = 1$. We can write

$$\|\mathbf{X}\|_2 = \max_{\substack{\mathbf{Z} \in \mathcal{C}_1^{[1]} \\ \|\mathbf{Z}\|_F = 1}} \max_{\|u^1\|_{V^1} = 1} \langle \mathbf{X}, u^1 \otimes \mathbf{Z} \rangle_F = \max_{\substack{\mathbf{Z} \in \mathcal{C}_1^{[1]} \\ \|\mathbf{Z}\|_F = 1}} \max_{\|u^1\|_{V^1} = 1} \sum_{i_1=1}^{n_1} \langle \mathbf{X}_{i_1}, \mathbf{Z} \rangle_F \cdot u^1(i_1).$$

By the Cauchy-Schwarz inequality, the inner maximum is achieved for $u^1 = x/\|x\|$ with $x(i_1) = \langle \mathbf{X}_{i_1}, \mathbf{Z} \rangle_F$ for $i_1 = 1, \dots, n_1$. This already yields the assertion. \square

2.3. Upper bounds from matricizations. Let $t \subsetneq \{1, \dots, d\}$ be nonempty. Then there exists a natural isometric isomorphism between the space $\mathbb{K}^{n_1 \times \dots \times n_d}$ and $\mathbb{K}^{\prod_{\mu \in t} n_\mu} \otimes \mathbb{K}^{\prod_{\nu \notin t} n_\nu}$. This isomorphism is called t -matricization (or t -flattening). More concretely, we can define two multi-index sets

$$\mathbf{I}^t = \times_{\mu \in t} \{1, \dots, n_\mu\}, \quad \mathbf{J}^t = \times_{\nu \notin t} \{1, \dots, n_\nu\}.$$

Then a tensor \mathbf{X} yields, in an obvious way, an $(\prod_{\mu \in t} n_\mu) \times (\prod_{\nu \notin t} n_\nu)$ matrix \mathbf{X}^t with entries

$$(2.6) \quad \mathbf{X}^t(\mathbf{i}, \mathbf{j}) = \mathbf{X}(i_1, \dots, i_d), \quad \mathbf{i} \in \mathbf{I}^t, \mathbf{j} \in \mathbf{J}^t.$$

The main observation is that \mathbf{X}^t is a rank-one matrix if \mathbf{X} is an elementary tensor (the converse is not true in general). Since we can always construct a tensor from its t -matricization, we obtain from the best-rank one approximation ratio for matrices that

$$\text{App}(\mathbb{V}) \leq \frac{1}{\sqrt{\min\left(\prod_{\mu \in t} n_\mu, \prod_{\nu \notin t} n_\nu\right)}}.$$

This is because $\|\mathbf{X}\|_2 \leq \|\mathbf{X}^t\|_2$ and $\|\mathbf{X}\|_F = \|\mathbf{X}^t\|_F$. Here the subset t is arbitrary. In combination with (1.9), this allows the following conclusion for tensors with one dominating mode size.

Proposition 2.3. *If there exists $\nu \in \{1, \dots, d\}$ such that $\prod_{\mu \neq \nu} n_\mu \leq n_\nu$, then*

$$\text{App}(\mathbb{V}) = \frac{1}{\sqrt{\min_{\nu=1, \dots, d} \prod_{\mu \neq \nu} n_\mu}},$$

that is, the trivial bound (1.9) is sharp.

For instance, $\text{App}_3(\mathbb{K}; n, n, n^2) = 1/n$.

2.4. Upper bounds from random tensors. We conclude this section with some known upper bounds obtained from random tensors. These results are obtained by combining coverings of the set of normalized (to Frobenius norm one) elementary tensors with concentration of measure results.

In [8] it is shown that for $d \geq 11$ the fraction of tensors \mathbf{X} on the unit sphere in $\mathbb{C}^{2 \times \dots \times 2}$ satisfying

$$\|\mathbf{X}\|_2^2 \leq \frac{1}{2^{d-2 \log_2 d - 3}}$$

is at least $1 - e^{-d^2}$.

More recently, [25] provides a simplified version of a result from [19], namely that

$$\|\mathbf{X}\|_2^2 \leq C \ln d \sum_{i=1}^d n_i$$

with any desired probability for real tensors with independent, zero-mean, sub-Gaussian entries satisfying $\mathbb{E}(e^{t\mathbf{X}_{i_1, \dots, i_d}}) \leq e^{\sigma^2 t^2/2}$, as long as the constant C is taken large enough. For example, when the elements are i.i.d. Gaussian, we have

$$\|\mathbf{X}\|_2^2 \leq C \ln d \sum_{i=1}^d n_i, \quad \|\mathbf{X}\|_F^2 \geq C' n_1 \cdots n_d$$

with probability larger than $1/2$ respectively, where the second inequality follows from the tail bound of the chi-squared distribution. Thus,

$$(2.7) \quad \frac{\|\mathbf{X}\|_2^2}{\|\mathbf{X}\|_F^2} \leq \frac{C'' \ln d \sum_{i=1}^d n_i}{n_1 \cdots n_d} \leq \frac{C'' d \ln d}{\min_{\nu=1, \dots, d} \prod_{\mu \neq \nu} n_\mu}$$

with positive probability. This shows that the naive lower bound (1.9), whether sharp or not, provides the right order for $\text{App}(\mathbb{V})$ (at least when $\mathbb{K} = \mathbb{R}$).

3. ORTHOGONAL AND UNITARY TENSORS

In this section we introduce the concept of orthogonal tensors. It is a “natural” extension of matrices with pairwise orthonormal rows or orthonormal columns. Orthogonal matrices play a fundamental role in both matrix analysis [10] and numerical computation [7, 20]. Although the concept of orthogonal tensors was proposed earlier in [6], we believe that our less abstract definition given below extends naturally from some properties of matrices with orthonormal rows or columns. As in the matrix case, we will see in the next section that orthogonality is a necessary and sufficient condition for a tensor to achieve the trivial bound (1.9) on the ratio between spectral and Frobenius norms. However, it also turns out that orthogonality for tensors is a very strong property and in many tensor spaces (configurations of (n_1, \dots, n_d) and the field \mathbb{K}) orthogonal tensors do not exist.

For ease of presentation we assume in the following that $n_1 \leq \dots \leq n_d$, but all definitions and results transfer to general tensors using suitable permutations of dimensions. In this sense, our recursive definition of orthogonal tensors generalizes matrices with pairwise orthonormal rows.

Definition 3.1. A tensor of order one, i.e., a vector $u^1 \in \mathbb{K}^{n_1}$, is called *orthogonal* for $\mathbb{K} = \mathbb{R}$ (resp. *unitary* for $\mathbb{K} = \mathbb{C}$), if its Euclidean norm equals one. Let $n_1 \leq n_2 \leq \dots \leq n_d$. Then $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$ is called *orthogonal* for $\mathbb{K} = \mathbb{R}$ (resp. *unitary* for $\mathbb{K} = \mathbb{C}$), if for every $u^1 \in \mathbb{K}^{n_1}$ with $\|u^1\|_2 = 1$, the tensor $\mathbf{X} \times_1 u^1$ is orthogonal (resp. unitary).

Since partial contractions commute, one could use the following, slightly more general definition of orthogonal (unitary) tensor of order $d \geq 2$ (which, e.g., subsumes matrices with orthonormal rows and columns). Let μ^* be such that $n_{\mu^*} \geq n_\mu$ for all μ . Then \mathbf{X} is orthogonal (unitary), if for any subset $S \subset \{1, 2, \dots, d\} \setminus \{\mu^*\}$ and any unit vectors $u^\mu \in \mathbb{K}^{n_\mu}$, the tensor $\mathbf{X} \times_{\mu \in S} u^\mu$ of order $d - |S|$ is orthogonal (unitary). In particular, $\mathbf{X} \times_\mu u^\mu$ is an orthogonal (unitary) tensor of order $d - 1$ for any $\mu \neq \mu^*$. It is clear that \mathbf{X} will be orthogonal (unitary) according to this definition if and only if for any permutation π of $\{1, \dots, d\}$ the tensor with entries $\mathbf{X}(i_{\pi(1)}, \dots, i_{\pi(d)})$ is orthogonal (unitary). Therefore, we can stick without loss of generality to consider the case where $n_1 \leq \dots \leq n_d$ and the Definition 3.1 of orthogonality (unitarity).

An alternative way to think of orthogonal and unitary tensors is as length-preserving $(d - 1)$ -form in the following sense. Every tensor $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$ defines a $(d - 1)$ -linear form

$$(3.1) \quad \begin{aligned} \omega_{\mathbf{X}} : \mathbb{R}^{n_1} \times \dots \times \mathbb{R}^{n_{d-1}} &\rightarrow \mathbb{R}^{n_d} \\ (u^1, \dots, u^{d-1}) &\mapsto \mathbf{X} \times_1 u^1 \times_2 u^2 \dots \times_{d-1} u^{d-1}. \end{aligned}$$

It is easy to obtain the following alternative, non-inductive definition of orthogonal (unitary) tensors.

Proposition 3.2. *Let $n_1 \leq \dots \leq n_d$. Then $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$ is orthogonal (unitary) if and only if*

$$\|\omega_{\mathbf{X}}(u^1, \dots, u^{d-1})\|_2 = \prod_{\mu=1}^{d-1} \|u^\mu\|_2$$

for all u^1, \dots, u^{d-1} .

For third-order tensors this property establishes an equivalence between orthogonal tensors and the Hurwitz problem that will be discussed in section 4.1.1. By considering subvectors of u^1, \dots, u^{d-1} , it further proves the following fact.

Proposition 3.3. *Let $n_1 \leq \dots \leq n_d$ and $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$ be orthogonal (unitary). Then any $n'_1 \times \dots \times n'_{d-1} \times n_d$ subtensor of \mathbf{X} is also orthogonal (unitary).*

We now list some extremal properties of orthogonal and unitary tensors related to spectral norm, nuclear norm and orthogonal rank.

Proposition 3.4. *Let $n_1 \leq \dots \leq n_d$ and $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$ be orthogonal (unitary). Then*

$$(a) \quad \|\mathbf{X}\|_2 = 1, \quad \|\mathbf{X}\|_F = \sqrt{\prod_{\mu=1}^{d-1} n_\mu}, \quad \|\mathbf{X}\|_* = \prod_{\mu=1}^{d-1} n_\mu,$$

$$(b) \text{rank}_\perp(\mathbf{X}) = \prod_{\mu=1}^{d-1} n_\mu.$$

Proof. Ad (a). It follows from orthogonality that all fibers $\mathbf{X}(i_1, \dots, i_{d-1}, :)$ fibers along dimension n_d have norm one (because the fibers can be obtained from contractions with standard unit vectors). There are $\prod_{\mu=1}^{d-1} n_\mu$ of such fibers, hence $\|\mathbf{X}\|_{\mathbb{F}}^2 = \prod_{\mu=1}^{d-1} n_\mu$. From the trivial bound (1.9) it then follows $\|\mathbf{X}\|_2 \geq 1$. On the other hand, by Cauchy-Schwarz inequality and orthogonality (Proposition 3.2),

$$\begin{aligned} |\langle \mathbf{X}, u^1 \otimes \dots \otimes u^d \rangle_{\mathbb{F}}| &= |\langle \omega_{\mathbf{X}}(u^1, \dots, u^{d-1}), u^d \rangle_{\mathbb{K}^{n_d}}| \\ &\leq \|\omega_{\mathbf{X}}(u^1, \dots, u^{d-1})\|_2 \|u^d\|_2 \leq \prod_{\mu=1}^d \|u^\mu\|_2. \end{aligned}$$

Hence $\|\mathbf{X}\|_2 \leq 1$. Now (1.6) and (1.7) together give the asserted value of $\|\mathbf{X}\|_*$.

Ad (b). Due to (a), this follows by combining (2.2) and (2.4). \square

Our main aim in this section is to establish that, as in the matrix case, the extremal values of the spectral and nuclear norms in Proposition 3.4 fully characterize multiples of orthogonal and unitary tensors.

Theorem 3.5. *Let $n_1 \leq \dots \leq n_d$ and $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$, $\mathbf{X} \neq 0$. The following are equivalent:*

- (a) \mathbf{X} is a scalar multiple of an orthogonal (resp. unitary) tensor,
- (b) $\frac{\|\mathbf{X}\|_2}{\|\mathbf{X}\|_{\mathbb{F}}} = \frac{1}{\sqrt{\prod_{\mu=1}^{d-1} n_\mu}}$,
- (c) $\frac{\|\mathbf{X}\|_*}{\|\mathbf{X}\|_{\mathbb{F}}} = \sqrt{\prod_{\mu=1}^{d-1} n_\mu}$.

In light of the trivial lower bound (1.9) on the spectral norm, and the upper bound (1.7) on the nuclear norm, the immediate conclusion from this theorem is the following.

Corollary 3.6. *Let $n_1 \leq \dots \leq n_d$. Then*

$$\text{App}_d(\mathbb{K}; n_1, \dots, n_d) = \frac{1}{\sqrt{\prod_{\mu=1}^{d-1} n_\mu}}.$$

if and only if orthogonal (resp. unitary) tensors exist in $\mathbb{K}^{n_1 \times \dots \times n_d}$. Otherwise, the value of $\text{App}_d(\mathbb{K}; n_1, \dots, n_d)$ is strictly larger. Analogously, it holds

$$\max_{\mathbf{X} \neq 0} \frac{\|\mathbf{X}\|_*}{\|\mathbf{X}\|_{\mathbb{F}}} = \sqrt{\prod_{\mu=1}^{d-1} n_\mu}$$

in $\mathbb{K}^{n_1 \times \dots \times n_d}$ if and only if orthogonal (resp. unitary) tensors exist. Otherwise, the maximum ratio must be strictly smaller.

Proof of Theorem 3.5. In the proof, we use the notation $n_1 \dots n_{d-1}$ instead of $\prod_{\mu=1}^{d-1} n_\mu$. By Proposition 3.4, (a) implies (b) and (c).

We show that (b) implies (a). The proof is by induction over d . For $d = 1$ spectral norm and Frobenius norm are equal. When $d = 2$, we have already mentioned in

section 1.3 that for $m \leq n$ only $m \times n$ matrices with pairwise orthonormal rows achieve $\|\mathbf{X}\|_F = \sqrt{m}$ and $\|\mathbf{X}\|_2 = 1$. Let now $d \geq 3$ and assume (b) always implies (a) for tensors of order $d - 1$. Consider $\mathbf{X} \in \mathbb{K}^{n_1 \times \dots \times n_d}$ with $\|\mathbf{X}\|_F^2 = n_1 \cdots n_{d-1}$ and $\|\mathbf{X}\|_2 = 1$. Then all the $n_1 \cdots n_{d-1}$ fibers $\mathbf{X}(i_1, \dots, i_{d-1}, :)$ parallel to the last dimension have Euclidean norm one, since otherwise one of these fibers has a larger norm, and so the corresponding rank-one tensor containing only that fiber (but normalized) provides a larger overlap with \mathbf{X} than one. As a consequence, the n_1 slices $\mathbf{X}_{i_1} = \mathbf{X}(i_1, :, \dots, :)$ $\in \mathbb{K}^{n_2 \times \dots \times n_{d-1}}$, $i_1 = 1, \dots, n_1$, have squared Frobenius norm $n_2 \cdots n_d$ and spectral norm one (by (1.9), $\|\mathbf{X}_{i_1}\|_2 \geq 1$, whereas by (2.5), $\|\mathbf{X}_{i_1}\|_2 \leq 1$). It now follows from the induction hypothesis and Proposition 3.4 that all slices are orthogonal (resp. unitary) tensors.

Now let $u^1 \in \mathbb{K}^{n_1}, \dots, u^{d-1} \in \mathbb{K}^{n_{d-1}}$ have norm one. We have to show that

$$\begin{aligned} \omega_{\mathbf{X}}(u^1, \dots, u^{d-1}) &= \mathbf{X} \times_1 u^1 \times_2 u^2 \cdots \times_{d-1} u^{d-1} \\ &= \sum_{i_1=1}^{n_1} u^1(i_1) (\mathbf{X}_{i_1} \times_2 u^2 \cdots \times_{d-1} u^{d-1}) \end{aligned}$$

has norm one.² Since the \mathbf{X}_{i_1} are orthogonal (resp. unitary), the vectors $v^{i_1} = \mathbf{X}_{i_1} \times_2 u^2 \cdots \times_{d-1} u^{d-1}$ have norm one. It is enough to show that they are pairwise orthogonal in \mathbb{K}^{n_d} . Without loss of generality assume to the contrary that $\langle v^1, v^2 \rangle \neq 0$. Then the matrix M with rows v^1 and v^2 has spectral norm larger than one. Hence there exist $\tilde{u} \in \mathbb{K}^2$ and $u^d \in \mathbb{K}^{n_d}$, both of norm one, such that for $u^1 = (\tilde{u}(1), \tilde{u}(2), 0, \dots, 0) \in \mathbb{K}^{n_1}$ it holds

$$|\langle \mathbf{X}, u^1 \otimes u^2 \otimes \cdots \otimes u^{d-1} \otimes u^d \rangle_F| = |\tilde{u}(1)\langle v^1, u^d \rangle + \tilde{u}(2)\langle v^2, u^d \rangle| = |\tilde{u}^T M u^d| > 1.$$

This contradicts $\|\mathbf{X}\|_2 = 1$.

We next prove that (c) implies (a). If (c) holds, we can assume that

$$(3.2) \quad \|\mathbf{X}\|_* = n_1 \cdots n_{d-1} = \|\mathbf{X}\|_F^2.$$

By Proposition 2.1, we can find a decomposition $\mathbf{X} = \sum_{k=1}^{n_1 \cdots n_{d-1}} \mathbf{Z}_k$ into $n_1 \cdots n_{d-1}$ mutually orthogonal elementary tensors $\mathbf{Z}_k \in \mathcal{C}_1$ such that $\|\mathbf{Z}_1\|_F = \|\mathbf{X}\|_2$. Using the definition (1.5) of nuclear norm, the Cauchy-Schwarz inequality, and (3.2) we obtain

$$\|\mathbf{X}\|_* \leq \sum_{k=1}^R \|\mathbf{Z}_k\|_F \leq \sqrt{n_1 \cdots n_{d-1}} \|\mathbf{X}\|_F = \|\mathbf{X}\|_*.$$

Hence the inequality signs are actually equalities. However, equality in the Cauchy-Schwarz inequality is only attained if all $\|\mathbf{Z}_k\|_F$ take the same value, namely

$$\|\mathbf{Z}_k\|_F = \frac{\|\mathbf{X}\|_F}{\sqrt{n_1 \cdots n_{d-1}}} = 1.$$

In particular, $\|\mathbf{Z}_1\|_F = \|\mathbf{X}\|_2$ has this value, which implies that \mathbf{X} is orthogonal (resp. unitary), since we have already proved that (b) implies (a). \square

Remark 3.7. We note for completeness that by Proposition 3.4 an orthogonal (resp. unitary) tensor has infinitely many best rank-one approximations and they are very

²The notation $\mathbf{X}_{i_1} \times_2 u^2 \cdots \times_{d-1} u^{d-1}$ is convenient although slightly abusive, since, e.g., \times_2 is strictly speaking a contraction in the first mode of \mathbf{X}_{i_1} .

easy to construct. In fact, given any unit vectors $u^\mu \in \mathbb{K}^{n_\mu}$ for $\mu = 1, \dots, d-1$, let $u^d = \mathbf{X} \times_1 u^1 \times_2 u^2 \cdots \times_{d-1} u^{d-1}$, which is also a unit vector. Then

$$|\langle \mathbf{X}, u^1 \otimes \cdots \otimes u^d \rangle_{\mathbb{F}}| = \|u^d\|_2^2 = 1 = \|\mathbf{X}\|_2,$$

which, by Proposition 1.1, shows that $u^1 \otimes \cdots \otimes u^d$ is a best rank-one approximation of \mathbf{X} .

4. EXISTENCE OF ORTHOGONAL AND UNITARY TENSORS

4.1. Third-order tensors. For a third-order tensor $\mathbf{X} \in \mathbb{K}^{\ell \times m \times n}$ with $\ell \leq m \leq n$, the lower bound (1.9) takes the form

$$(4.1) \quad \frac{\|\mathbf{X}\|_2}{\|\mathbf{X}\|_{\mathbb{F}}} \geq \frac{1}{\sqrt{\ell m}}.$$

By Theorem 3.5, equality can be only achieved for orthogonal (resp. unitary) tensors. From Proposition 2.3 we know that this estimate is sharp in the case $\ell m \leq n$. In fact, an orthogonal tensor can be then easily constructed via its slices

$$\mathbf{X}(i, :, :) = \underbrace{[0 \ \cdots \ 0]}_{m \times m(i-1)} \ [Q_i \ 0 \ \cdots \ 0] \in \mathbb{K}^{m \times n}, \quad i = 1, \dots, \ell,$$

where the entries represent blocks of size $m \times m$ (except the last block might have more columns), and the $Q_i \in \mathbb{K}^{m \times m}$ are matrices with pairwise orthonormal rows at position i .

In this section we inspect the sharpness in the case $\ell m > n$, where such a construction is not possible in general. Interestingly, the results depend on the underlying field.

4.1.1. Real case; Relation to Hurwitz problem. By Proposition 3.2, a third-order tensor $\mathbf{X} \in \mathbb{K}^{\ell \times m \times n}$ is orthogonal if and only if the bilinear form $\omega_{\mathbf{X}}(u, v) = \mathbf{X} \times_1 u \times_2 v$ satisfies

$$(4.2) \quad \|\omega_{\mathbf{X}}(u, v)\|_2 = \|u\|_2 \|v\|_2$$

for all $u \in \mathbb{R}^\ell$, $v \in \mathbb{R}^m$. In the real case $\mathbb{K} = \mathbb{R}$, this relation can be written as

$$(4.3) \quad \sum_{k=1}^n \omega_k^2 = \left(\sum_{i=1}^{\ell} u_i^2 \right) \left(\sum_{j=1}^m v_j^2 \right).$$

The question of whether for a given triple $[\ell, m, n]$ of dimensions a bilinear form $\omega(u, v)$ exists obeying this relation is known as the Hurwitz problem (here for the field \mathbb{R}). If a solution exists, the triple $[\ell, m, n]$ is called *admissible* for the Hurwitz problem. We hence have the following result (Theorem 3.5 yields the second part).

Theorem 4.1. *Let $\ell \leq m \leq n$. A tensor $\mathbf{X} \in \mathbb{R}^{\ell \times m \times n}$ is orthogonal if and only if the induced bilinear form $\omega_{\mathbf{X}}$ is a solution to the Hurwitz problem (4.3). Correspondingly, it holds*

$$\text{App}_3(\mathbb{R}; k, \ell, n) = \frac{1}{\sqrt{\ell m}}$$

if and only if $[\ell, m, n]$ is an admissible triple for the Hurwitz problem.

Some admissible cases (besides $\ell m \leq n$) known from the literature are discussed next.

$n \times n \times n$ tensors and composition algebras. In the classical work [11], Hurwitz considered the case $\ell = m = n$. In this case the bilinear form $w_{\mathbf{X}}$ turns \mathbb{R}^n into an algebra on \mathbb{R}^n . In modern terminology, an algebra on \mathbb{R}^n satisfying the relation (4.3) for its product $u \cdot v = \omega$ is called a composition algebra. Hurwitz disproved the existence of such an algebra for the cases $n \neq 1, 2, 4, 8$.³

For the cases $n = 1, 2, 4, 8$, the real field \mathbb{R} , the complex field \mathbb{C} , the quaternion algebra \mathbb{H} and the octonion algebra \mathbb{O} are composition algebras on \mathbb{R}^n , respectively, since the corresponding multiplications are length preserving. Consequently, examples for orthogonal $n \times n \times n$ tensors are given by the multiplication tensors of these algebras. For completeness we list them here.

For $n = 1$ this is just $\mathbf{X} = 1$. For $n = 2$, let e_1, e_2 denote the unit vectors in \mathbb{R}^2 , then

$$(4.4) \quad \mathbf{X}_{\mathbb{C}} = \begin{bmatrix} e_1 & e_2 \\ e_2 & -e_1 \end{bmatrix} \in \mathbb{R}^{2 \times 2 \times 2}$$

is orthogonal. This is the tensor of multiplication in $\mathbb{C} \cong \mathbb{R}^2$.

For $n = 4$, let e_1, e_2, e_3, e_4 denote the unit vectors in \mathbb{R}^4 , then

$$(4.5) \quad \mathbf{X}_{\mathbb{H}} = \begin{bmatrix} e_1 & e_2 & e_3 & e_4 \\ e_2 & -e_1 & e_4 & -e_3 \\ e_3 & -e_4 & -e_1 & e_2 \\ e_4 & e_3 & -e_2 & -e_1 \end{bmatrix} \in \mathbb{R}^{4 \times 4 \times 4}$$

is orthogonal. This is the tensor of multiplication in the quaternion algebra $\mathbb{H} \cong \mathbb{R}^4$.

For $n = 8$, let e_1, \dots, e_8 denote the unit vectors in \mathbb{R}^8 , then

$$(4.6) \quad \mathbf{X}_{\mathbb{O}} = \begin{bmatrix} e_1 & e_2 & e_3 & e_4 & e_5 & e_6 & e_7 & e_8 \\ e_2 & -e_1 & e_4 & -e_3 & e_6 & -e_5 & -e_8 & e_7 \\ e_3 & -e_4 & -e_1 & e_2 & e_7 & e_8 & -e_5 & -e_6 \\ e_4 & e_3 & -e_2 & -e_1 & e_8 & -e_7 & e_6 & -e_5 \\ e_5 & -e_6 & -e_7 & -e_8 & -e_1 & e_2 & e_3 & e_4 \\ e_6 & e_5 & -e_8 & e_7 & -e_2 & -e_1 & -e_4 & e_3 \\ e_7 & e_8 & e_5 & -e_6 & -e_3 & e_4 & -e_1 & -e_2 \\ e_8 & -e_7 & e_6 & e_5 & -e_4 & -e_3 & e_2 & -e_1 \end{bmatrix} \in \mathbb{R}^{8 \times 8 \times 8}$$

is orthogonal. This is the tensor of multiplication in the octonion algebra $\mathbb{O} \cong \mathbb{R}^8$.

For reference we summarize the $n \times n \times n$ case.

Theorem 4.2. *Real orthogonal $n \times n \times n$ tensors exist only for $n = 1, 2, 4, 8$. Consequently,*

$$\text{App}_3(\mathbb{R}; n, n, n) = \frac{1}{n}$$

if and only if $n = 1, 2, 4, 8$. Otherwise, the value of $\text{App}_3(\mathbb{R}; n, n, n)$ must be larger.

Other admissible triples. There exists an impressive body of work for identifying admissible triples for the Hurwitz problem, in particular over the finite field of integers (so called *sum-of-squares formulas*). The problem can be considered as open in general. We list some of the available results here. We refer to [23] for an introduction into the subject, and to [17] for latest results and references.

³In fact, when \mathbf{X} is orthogonal, $\omega_{\mathbf{X}}$ turns \mathbb{R}^n into a division algebra. By a much deeper result, these algebras also only exist for $n = 1, 2, 4, 8$.

Regarding triples $[\ell, m, n]$ with $\ell \leq m \leq n$ we can observe that if a configuration is feasible, then so is $[\ell', m', n']$ with $\ell' \leq \ell$, $m' \leq m$, and $n' \geq n$. This follows directly from (4.3), since we can consider subvectors of u and v , and artificially expand the left sum with $\omega_k = 0$. As stated previously, $n \geq \ell m$ is always admissible. Let

$$\ell * m := \min\{n: [\ell, m, n] \text{ is admissible}\},$$

i.e., the minimal n for (4.3) to exist. For $\ell \leq 9$ these values can be recursively computed for all s according to the rule [23, Prop. 12.9 and 12.13]:

$$\ell * m = \begin{cases} 2(\lceil \frac{\ell}{2} \rceil * \lceil \frac{m}{2} \rceil) - 1 & \text{if } \ell, m \text{ are both odd and } \lceil \frac{\ell}{2} \rceil * \lceil \frac{m}{2} \rceil = \lceil \frac{\ell}{2} \rceil + \lceil \frac{m}{2} \rceil - 1, \\ 2(\lceil \frac{\ell}{2} \rceil * \lceil \frac{m}{2} \rceil) & \text{else.} \end{cases}$$

This provides the table [23]:

For $10 \leq \ell \leq 16$, the values of $\ell * m$ are given in the following table due to Yiu [29]:

There are also infinite families of admissible triples known. Radon [22] and Hurwitz [12] independently determined the largest $\ell \leq n$ for which the triple $[\ell, n, n]$ is admissible: writing $n = 2^{4\alpha+\beta}\gamma$ with $\beta \in \{0, 1, 2, 3\}$ and γ odd, the maximal admissible value of ℓ is

$$\ell = 2^\beta + 8\alpha.$$

Some known families of admissible triples “close” to Hurwitz–Radon triples are

$$\left[2 + 8\alpha, 2^{4\alpha} - \binom{4\alpha}{2\alpha}, 2^{4\alpha} \right] \quad \text{and} \quad [2\alpha, 2^\alpha - 2\alpha, 2^\alpha - 2], \quad \alpha \in \mathbb{N}.$$

We refer once more to [17] for more results of this type.

4.1.2. *Complex case.* In the complex case, the answer to the existence of unitary tensors in the case $\ell m > n$ is very simple: they do not exist. Note that for $2 \times 2 \times 2$ complex tensors, this is confirmed by the fact that $\text{App}_3(\mathbb{C}; 2, 2, 2) \geq 1/\sqrt{3}$ from [16].

Theorem 4.3. *Let $\ell \leq m \leq n$. When $\ell m > n$, there exists no unitary tensor in $\mathbb{C}^{\ell \times m \times n}$, and hence*

$$\text{App}_3(\mathbb{C}; \ell, m, n) > \frac{1}{\sqrt{\ell m}}.$$

Proof. Suppose to the contrary that some $\mathbf{X} \in \mathbb{C}^{\ell \times m \times n}$ is unitary. Let $X_i = \mathbf{X}(i, :, :) \in \mathbb{C}^{m \times n}$ denote the slices of \mathbf{X} perpendicular to the first mode. By definition, $\sum_{i=1}^{\ell} u(i)X_i$ is unitary (has pairwise orthonormal rows) for all unit vectors $u \in \mathbb{C}^{\ell}$. In particular, every X_i is unitary. For $i \neq j$ we then find that $X_i + X_j$ is $\sqrt{2}$ times a unitary matrix, so

$$2I_m = (X_i + X_j)(X_i + X_j)^* = 2I_m + X_i X_j^* + X_j X_i^*,$$

that is, $X_j X_i^* + X_i X_j^* = 0$. But also we see that $X_i + iX_j$ is also $\sqrt{2}$ times a unitary matrix, so

$$2I_m = (X_i + iX_j)(X_i + iX_j)^* = (X_i + iX_j)(X_i^* - iX_j^*) = 2I_m + i(X_j X_i^* - X_i X_j^*),$$

that is, $X_j X_i^* - X_i X_j^* = 0$. We conclude that $X_j X_i^* = 0$ for all $i \neq j$. This would mean that the ℓ row spaces of the matrices X_i are pairwise orthogonal subspaces in \mathbb{C}^n , but each of dimension m . Since $\ell m > n$, this is not possible. \square

The above result appears surprising in comparison to the real case. In particular, it admits the following remarkable corollary on a slight variation of the Hurwitz problem. The statement has a classical feel, but since we have been unable to find it in the literature, we emphasize it here. As a matter of fact, our proof of non-existence of unitary tensors as conducted above resembles the main logic of contradiction in Hurwitz' original proof [11], but under stronger assumptions that rule out all dimensions $n > 1$. The subtle difference to Hurwitz' setup is that the function $u \mapsto \|u\|_2^2$ is not a quadratic form on \mathbb{C}^n over the field \mathbb{C} (it is not \mathbb{C} -homogenous), but generated by a sesqui-linear form.

Corollary 4.4. *If $n > 1$, then there exists no bilinear map $\omega: \mathbb{C}^n \times \mathbb{C}^n \rightarrow \mathbb{C}^n$ such that*

$$\|\omega(u, v)\|_2 = \|u\|_2 \|v\|_2$$

for all $u, v \in \mathbb{C}^n$.

Proof. Since bilinear forms from $\mathbb{C}^n \times \mathbb{C}^n$ to \mathbb{C}^n are in one-to-one correspondence with complex $n \times n \times n$ tensors via (3.1), the assertion follows from Theorem 4.3 due to Proposition 3.2. \square

We note that while unitary tensors do not exist when $\ell m > n$, when $\ell m \leq n$ they do exist, by Proposition 2.3.

4.2. Implications to tensor spaces of order larger than three. Obviously, it follows from the recursive nature of the definition that orthogonal (resp. unitary) tensors of size $n_1 \times \cdots \times n_d \times n_{d+1}$, where $n_1 \leq \cdots \leq n_d \leq n_{d+1}$, can only exist, if orthogonal (resp. unitary) tensors of size $n_1 \times \cdots \times n_d$ exist. This rules out for instance the existence of orthogonal and unitary $3 \times 3 \times 3 \times 3$ tensors.

In the real case, the construction of orthogonal $n \times n \times n$ tensors from the multiplication tables (4.4)–(4.6) in section 4.1.1 is very explicit. The construction can be extended to higher order as follows.

Theorem 4.5. *Let $d \geq 2$, $n \in \{2, 4, 8\}$, $n_1 \leq \dots \leq n_d$ and $\mathbf{X} \in \mathbb{R}^{n_1 \times \dots \times n_d}$ be orthogonal. For any fixed $\mu \in \{1, \dots, d-1\}$ satisfying $n \leq n_\mu$, take any n slices $\mathbf{X}_1, \dots, \mathbf{X}_n \in \mathbb{R}^{[\mu]}$ from \mathbf{X} perpendicular to mode μ . Then a real orthogonal tensor of order $d+1$ and size $n_1 \times \dots \times n_{\mu-1} \times n \times n \times n_{\mu+1} \times \dots \times n_d$ can be constructed from the tables (4.4)–(4.6), respectively, using \mathbf{X}_k instead of e_k .*

The proof is given further below. As an example, $[10, 10, 16]$ is an admissible triple by the table (4.7). Hence, by the theorem above, orthogonal tensors of size $8 \times \dots \times 8 \times 10 \times 16$ exist for any number $d-2$ of 8's. So the naive bound (1.9) (which equals $1/\sqrt{10 \cdot 8^{d-2}}$ in this example) for the best rank-one approximation ratio is sharp in $\mathbb{R}^{8 \times \dots \times 8 \times 10 \times 16}$. This is in contrast to the restrictive condition in Proposition 2.3. In particular, in light of Theorem 4.2, we have the following immediate corollary of Theorem 4.5.

Corollary 4.6. *Real orthogonal $n \times \dots \times n$ tensors of order $d \geq 3$ exist if and only if $n = 1, 2, 4, 8$. Consequently,*

$$\text{App}_d(\mathbb{R}; n, \dots, n) = \frac{1}{\sqrt{n^{d-1}}}$$

if and only if $n = 1, 2, 4, 8$ for $d \geq 3$. Otherwise, the value of $\text{App}_d(\mathbb{R}; n, \dots, n)$ must be larger.

In combination with Proposition 3.3, this corollary implies that lots of orthogonal tensors in low dimensions exist.

Corollary 4.7. *If $\max_{1 \leq \mu \leq d} n_\mu = 1, 2, 4, 8$, then orthogonal tensors exist in $\mathbb{R}^{n_1 \times \dots \times n_d}$.*

Proof of Theorem 4.5. Without loss of generality, we assume $\mu = 1$. Let $\mathbf{Y} \in \mathbb{R}^{n \times n \times n_2 \times \dots \times n_d}$ be a tensor constructed in the way described in the statement from an orthogonal tensor \mathbf{X} . The slices \mathbf{X}_k of \mathbf{X} are then orthogonal tensors of size $n_2 \times \dots \times n_d$. The Frobenius norm of \mathbf{Y} takes the correct value

$$\|\mathbf{Y}\|_F = \sqrt{n^2 \cdot \prod_{\mu=2}^{d-1} n_\mu}.$$

According to Theorem 3.5(a), we hence have to show that $\|\mathbf{Y}\|_2 = 1$. By (1.9), it is enough to show $\|\mathbf{Y}\|_2 \leq 1$. To do so, let $\omega(u, v) = \mathbf{X}_* \times_1 u \times_2 v$ denote the multiplication in the composition algebra \mathbb{R}^n , that is, \mathbf{X}_* is the corresponding multiplication tensor $\mathbf{X}_{\mathbb{C}}$, $\mathbf{X}_{\mathbb{H}}$ or $\mathbf{X}_{\mathbb{O}}$ from (4.4)–(4.6) depending on the considered value of n . Then it holds

$$(4.8) \quad \mathbf{Y} \times_1 u \times_2 v = \sum_{k=1}^n \omega_k(u, v) \mathbf{X}_k.$$

Let $\|u\|_2 = \|v\|_2 = 1$. Then, by (4.2), $\|\omega(u, v)\|_2 = 1$. Let further \mathbf{Z} be a rank-one tensor in $\mathbb{R}^{n_2 \times \dots \times n_d}$ of Frobenius norm one. By (4.8) and the Cauchy-Schwarz inequality, it then follows that

$$|\langle \mathbf{Y}, u \otimes v \otimes \mathbf{Z} \rangle_F|^2 = \left(\sum_{k=1}^n \omega_k(u, v) \langle \mathbf{X}_k, \mathbf{Z} \rangle_F \right)^2 \leq \sum_{k=1}^n |\langle \mathbf{X}_k, \mathbf{Z} \rangle_F|^2.$$

By Proposition 2.2, the right expression is bounded by $\|\mathbf{X}\|_2^2$, which equals one by Theorem 3.5(a). This proves $\|\mathbf{Y}\|_2 \leq 1$. \square

5. ACCURATE COMPUTATION OF SPECTRAL NORM

In this section, we present some numerical experiments regarding the computation of spectral norm. We compare state-of-the-art algorithms implemented in the Tensorlab [27] toolbox with our own implementation of an alternating SVD method that has been proposed for more accurate spherical maximization of multilinear forms via two-factor updates. It will be briefly explained in section 5.1.

The summary of algorithms that we used for our numerical results is as follows.

cpd: This is the standard built-in algorithm for low-rank CP approximation in Tensorlab. To obtain the spectral norm, we use it for computing the best rank-one approximation. Internally, **cpd** uses certain problem-adapted nonlinear least-squares algorithms [24]. When used for rank-one approximation as in our case, the initial rank-one guess $u^1 \otimes \cdots \otimes u^d$ is obtained from the truncated higher-order singular value decomposition (HOSVD) [2, 3], that is, u^μ is computed as a dominant left singular vector of a $\{\mu\}$ -matricization ($t = \{\mu\}$ in (2.6)) of tensor \mathbf{X} . The rank-one tensor obtained in this way is known to be nearly optimal in the sense that $\|\mathbf{X} - u^1 \otimes \cdots \otimes u^d\|_F \leq \sqrt{d}\|\mathbf{X} - \mathbf{Y}_1\|_F$, where \mathbf{Y}_1 is a best rank-one approximation.

cpd (random): The same method, but using an option to use a random initial guess $u^1 \otimes \cdots \otimes u^d$.

ASVD (random): Our implementation of the ASVD method using the same random initial guess as **cpd (random)**.

ASVD (cpd): The ASVD method using the result of **cpd (random)** (which was often better than **cpd**) as initial guess, i.e., ASVD is used for further refinement. The improvement in experiments 5.2–5.4 is negligible (which indicates rather strong local optimality conditions for the **cpd (random)** solution), and so results for this method are only reported for random tensors in section 5.5.

5.1. The ASVD method. The ASVD method is an iterative method to compute spectral norm and best rank-one approximation of a tensor via (1.1). In contrast to the higher-order power method (which updates one factor at a time), it updates two factors of a current rank-one approximation $u^1 \otimes \cdots \otimes u^d$ simultaneously, while fixing the others, in some prescribed order. This strategy has been initially proposed in [3] (without any numerical experiments), and then later in more detail in [5]. Update of two factors has also been used in a framework of maximum block improvement method in [1]. Convergence analysis for this type of method has been conducted recently in [28].

In our implementation of ASVD the ordering of the updates is overlapping in the sense that we cycle between updates of (u^1, u^2) , (u^2, u^3) , and so on. Assume that the algorithm tries to update the first two factors u^1 and u^2 while u^3, \dots, u^d are fixed. To maximize the value $\langle \mathbf{X}, u^1 \otimes u^2 \otimes \cdots \otimes u^d \rangle_F$ for u^1, u^2 with $\|u^1\| = \|u^2\| = 1$, we use the simple fact that

$$\langle \mathbf{X}, u^1 \otimes u^2 \otimes \cdots \otimes u^d \rangle_F = (u^1)^T (\mathbf{X} \times_3 u^3 \cdots \times_d u^d) u^2.$$

Therefore, we can find the maximizer (u^1, u^2) as the the top left and right singular vectors of the matrix $\mathbf{X} \times_3 u^3 \cdots \times_d u^d$.

TABLE 1. Spectral norm estimations for orthogonal tensors

5.2. Orthogonal tensors. We start by testing the above methods for the orthogonal tensors (4.4)–(4.6), for which we know that the spectral norm after normalization is $1/n$. The result is shown in Table 1: all the methods easily find a best rank-one approximation. It is worth noting that the computed approximants are not always the same, due to the nonuniqueness described in Remark 3.7.

5.3. Fourth-order tensors with known spectral norm. In [9], the following examples of fourth-order tensors with known spectral norms are presented. Let

$$\mathbf{X} = \sum_{i=1}^m A_i \otimes B_i \text{ with } A_i, B_i \in \mathbb{R}^{n \times n} \text{ being symmetric,}$$

such that all the eigenvalues of A_i and B_i are in $[-1, 1]$, and there are precisely two fixed unit vectors $a, b \in \mathbb{R}^n$ (up to trivial scaling by -1) satisfying

$$a^T A_i a = b^T B_i b = 1, \quad i = 1, \dots, m.$$

Clearly, for any unit vectors $x, y, z, w \in \mathbb{R}^n$, one has $x^T A_i y \leq 1$ and $y^T B_i w \leq 1$, and so

$$\langle \mathbf{X}, x \otimes y \otimes z \otimes w \rangle_{\mathbb{F}} \leq m = \langle \mathbf{X}, a \otimes a \otimes b \otimes b \rangle_{\mathbb{F}}.$$

Therefore, $\|\mathbf{X}\|_2 = m$ and $m \cdot a \otimes a \otimes b \otimes b$ is a best rank-one approximation. Moreover, it is not difficult to check that a is the dominant left singular vector of the first ($t = \{1\}$ in (2.6)) and second ($t = \{2\}$) principal matrix unfolding of \mathbf{X} , while b is the dominant left singular vector of the third and fourth principal matricization. Therefore, for tensors of the considered type, the higher-order SVD truncated to rank one yields a best rank-one approximation $m \cdot a \otimes a \otimes b \otimes b$.

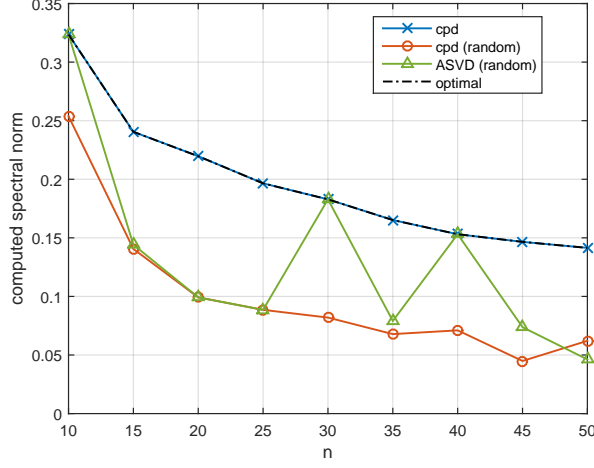


FIGURE 2. Results for fourth-order tensors with known spectral norms.

We construct tensors \mathbf{X} of this type for $n = 10, 15, 20, \dots, 50$ and $m = 10$, normalize them to Frobenius norm one (after normalization the spectral norm is $m/\|\mathbf{X}\|_{\mathbb{F}}$), and apply the considered methods. The results are shown in Figure 2. As explained above, the method cpd uses HOSVD for initialization, and indeed found the optimal factors a and b immediately. Therefore, the corresponding curve in Figure 2 matches the precise value of the spectral norm. We observe that for most n , the methods with random initialization found only suboptimal rank-one approximations. However, ASVD often found better approximations, and in particular found optimal solutions for $n = 10, 30, 40$.

5.4. Fooling HOSVD initialization. In the previous experiment the HOSVD truncation yielded the best rank-one approximation. It is possible to construct tensors for which the truncated HOSVD is not a good choice for initialization.

Take for instance an $n \times n \times n$ tensor \mathbf{X}_n with slices

$$(5.1) \quad \mathbf{X}_n(:, :, k) = S_n^{k-1},$$

where $S_n \in \mathbb{R}^{n \times n}$ is the “shift” matrix:

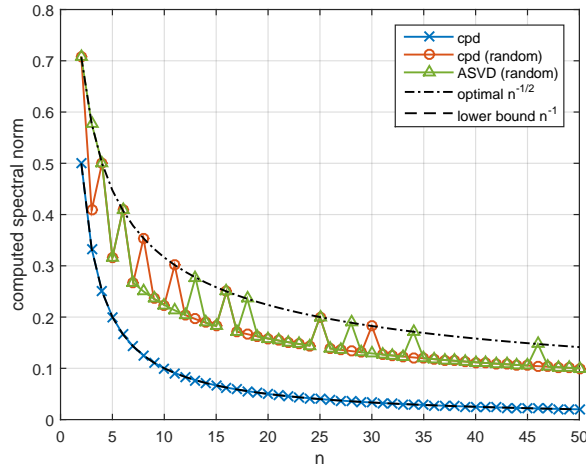
$$S_n = \begin{bmatrix} 0 & 1 & & & \\ & 0 & 1 & & \\ & & \ddots & \ddots & \\ & & & 0 & 1 \\ 1 & & & & 0 \end{bmatrix}.$$

This tensor has strong orthogonality properties: in any direction, the slices are orthogonal matrices, and parallel slices are pairwise orthogonal in the Frobenius inner product. In particular, $\|\mathbf{X}_n\|_F = n$. However, \mathbf{X}_n is not an orthogonal tensor in the sense of Definition 3.1, since $\|\mathbf{X}_n\|_2 = \sqrt{n}$ (use Proposition 2.2). A possible (there are many) best rank-one approximation for \mathbf{X}_n is given by the “constant” tensor whose entries all equal $1/n$. Nevertheless, we observed that the method `cpd` estimates the spectral norm of \mathbf{X}_n to be one, which, besides being a considerable underestimation for large n , would suggest that this tensor is orthogonal. Figure 3 shows the experimental results for the normalized tensors \mathbf{X}_n/n and $n = 2, 3, \dots, 50$.

The explanation is as follows. The three principal matricization of \mathbf{X}_n into an $n \times n^2$ matrix all have pairwise orthogonal rows of length \sqrt{n} . The left singular vectors are hence just the unit vectors e_1, \dots, e_n . Consequently, the truncated HOSVD yields a rank-one tensor $e_i \otimes e_j \otimes e_k$ with $\mathbf{X}_n(i, j, k) = 1$ as a starting guess. Obviously, $\langle \mathbf{X}_n, e_i \otimes e_j \otimes e_k \rangle_F = 1$. The point is that $e_i \otimes e_j \otimes e_k$ is a critical point for the spherical maximization problem (and thus also for the corresponding rank-one approximation problem (1.3))

$$(5.2) \quad \max f(u^1, u^2, u^3) = \langle \mathbf{X}_n, u^1 \otimes u^2 \otimes u^3 \rangle_F \quad \text{s.t.} \quad \|u^1\|_2 = \|u^2\|_2 = \|u^3\|_2 = 1.$$

To see this, note that $u^1 = e_i$ is the optimal choice for fixed $u^2 = e_j$ and $u^3 = e_k$, since \mathbf{X}_n has no other nonzero entries in fiber $\mathbf{X}_n(:, j, k)$ except at position i . Therefore, the partial derivative $h^1 \mapsto f(h^1, e_j, e_k)$ vanishes with respect to the first spherical constraint, i.e., when $h^1 \perp e_i$ (again, this can be seen directly since such

h^1 has a zero entry at position i). The observation is similar for other directions. As a consequence, $e_i \otimes e_j \otimes e_k$ will be a fixed-point of nonlinear optimization methods for (5.2) relying on the gradient or block optimization, thereby providing the function value $f(e_i, e_j, e_k) = 1$ as spectral norm estimate.

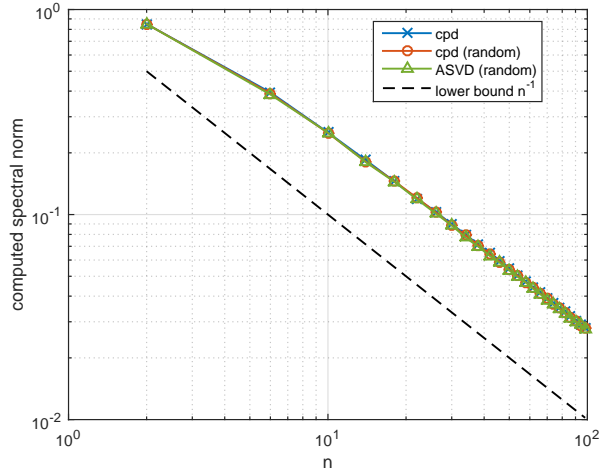
Note that a starting guess $e_i \otimes e_j \otimes e_k$ for computing $\|\mathbf{X}_n\|_2$ will also fool any reasonable implementation of ASVD. While for, say, fixed $u^3 = e_k$, any rank-one matrix $u^1 \otimes u^2$ of Frobenius norm one will maximize $\langle \mathbf{X}_n, u^1 \otimes u^2 \otimes e_k \rangle_F = (u^1)^T S_n^{k-1} u^2$, its computation via an SVD of S_n^{k-1} will again provide some unit vectors $u^1 = e_i$ and $u^2 = e_j$. We conclude that random starting guesses are crucial in this example. But even then, Figure 3 indicates that there are other suboptimal points of attraction.

5.5. Spectral norms of random tensors. Finally, we present some numerical results for random tensors. In this scenario, Tensorlab’s `cpd` output can be slightly improved using ASVD. Table 2 shows the computed spectral norms averaged over 10 samples of real random $20 \times 20 \times 20$ tensors whose entries were drawn from the standard Gaussian distribution. Table 3 repeats the experiment but with a different size $20 \times 20 \times 20 \times 20$. In both experiments, ASVD improved the output of `cpd` in the order of 10^{-3} and 10^{-4} , respectively, yielding the best (averaged) result.

Figure 4 shows the averaged spectral norm estimations of real random $n \times n \times n$ tensor for varying n together with the naive lower bound $1/n$ for the best-rank one approximation ratio (we omit the curve for ASVD (random) as it does not look very different from the other ones in the double logarithmic scale). The average is taken over 20 random tensors for each n . From Theorem 4.2 we know that the lower bound

is not tight for $n \neq 1, 2, 4, 8$. Nevertheless, we observe an asymptotic order $O(1/n)$ for the spectral norms of random tensors. This illustrates the theoretical results mentioned in section 2.4. In particular, $\text{App}_3(\mathbb{R}; n, n, n) = O(1/n)$ as indicated by (2.7).
